All orders require a non refundable 25% deposit paid on or before the date specified on the 'Order Confirmation'. The deposit amount is non-refundable and will be forfeited if the customer decides to cancel the order. Deposit amount can't be applied to take partial quantity of total ordered plants.

All cheques payable to 'FLORAMAXX TECHNOLOGIES LTD.' A fee of \$25.00 will be charged for all returned cheques. e-transfers can be sent to info@floramaxx.ca. We also accept wire transfers, please ask for the wire transfer details.

All accounts will be in cash or cash on delivery until credit is approved. For customers with approved credit, invoices are due on a 30-day net basis. Finance charges will accrue @2.0% per month on amounts past 60 days and will be collected.
